# SUPPORT OUR ZONE CENTRES

## THE NETBALL CENTRAL ZONE COMMUNITY TEAM HAS WORKED CLOSELY WITH THE CENTRES TO ALIGN A COMMON THREAD ACROSS ALL DEVELOPMENTAL INITIATIVES THROUGH PRODUCTIVE COMMUNICATION AND FEEDBACK.

As a result, increased development and networking opportunities presented during 2016 enhanced expertise across junior, coach, umpiring, team management and administration leading to further progression across the Zone.

## COMMUNITY DEVELOPMENT AND CENTRES

- The two-day annual Zone Forum was facilitated in September by Netball Central Zone at ASB Sports Centre, in collaboration with a number of valued partners and stakeholders including Sport New Zealand (SNZ), Netball New Zealand (NNZ), Centres and Sport Wellington. This year the Zone connected with NB Training, Ernst and Young, Eastern Institute of Technology, NZ Safety Brokers and Toyota to offer workshops in business best practice, sport management and exercise science. The forum aimed to update and provide development opportunities for staff involved in junior, coach, umpiring, team management and administration.

- Bi-annual Netball Development Officer (NDO) Forums were delivered in June and November at Vautier Park in Palmerston North by the Zone, providing officers with development workshops and networking opportunities with other Centres from across the Central Zone.
- A number of successfully hosted Zone and National events were managed and partnered in by some of our Centres:
  - Netball Taranaki hosted the North Island U15 Championships
  - Netball Wanganui hosted Lower North Island Secondary Schools (LNISS)
  - Netball Hutt Valley hosted New Zealand Secondary Schools (NZSS) at the newly developed Walter Nash Centre in collaboration with NNZ
- The Zone successfully hosted the third Super Club-Super School Invitational Tournament at Arena Manawatu in Palmerston North, featuring 10 club teams from across the Zone and 10 secondary schools who competed at Lower North Island Secondary Schools. The inclusive event provided development opportunities for coaches through a workshop delivered by Waimarama Taumaunu, umpires through Linda Liggins and Anne Blomfield (NZUDG) and bench officials through game delivery.

## GROW PARTICIPATION

Netball New Zealand's (NNZ) official national junior programme ANZ futureFERNs continued to show growth in the Year 1-4 space. Highlights for Netball Central Zone in junior netball in 2016 included:

- 17,553 juniors playing in the Year 1-8 space across the Zone.
- 13 Centres delivering ANZ futureFERNs at Year 1 & 2 and 12 delivering at Year 3 & 4.
- 5723 juniors at Year 1-4 participated in ANZ futureFERNs in 2016.
- Year 1 & 2 affiliation numbers increased 8.4 percent and Year 3 & 4 increased 10.2 percent across the Zone in 2016.
- Netball Hutt Valley delivered the second ANZ futureFERNs Zone Festival in collaboration with the Zone and NNZ, providing skills sessions for children Year 1-6 at Walter Nash Centre.
- 916 coaches attended ANZ futureFERNs workshops.
- Netball Horowhenua, Netball Manawatu, Netball Hutt Valley, Netball Wellington and Netball Wanganui increased their participation numbers significantly across all the Year 1-4 junior space.
- Kapi Mana introduced the ANZ futureFERNs programme for the first time, instigating growth in the Year 1 & 2 age group.

- The next phase of ANZ futureFERNs (6v6) will be rolled out in seven Centres across the Central Zone during 2017.

### **FACILITATION DEVELOPMENT OF COACHES, MANAGERS, UMPIRES, OFFICIALS AND VOLUNTEERS**

In her role as Netball Central Zone Coach Development Officer, Sandra Edge actively engaged with our valued Centres to provide opportunities and support. Highlights for 2016 included:

- 86 Netball New Zealand Coach Developing Modules were delivered this year around the Zone with 621 coaches attending the modules in total. Fifty-two coaches gained their CCA award this year.
- Coach Developer opportunities were piloted and delivered in partnership with Sport Wellington. These workshops were delivered in Wellington and Hutt Valley with Centre development staff – Maria Hegarty (Wellington), John Noho (Wellington), Kirsten Behl (Hutt Valley), Lynette Imrie (Hutt Valley), Carmell Wagg (Kapiti) and Sandy Biel (Wairarapa).
- Further coach developer opportunities were provided for all Centre development staff at the NDO Forum in June at Massey University which included Ann Rodgers and Savarna Wilton (Taranaki), Denise Aiolupotea and Natalie Corbett (Hawke's Bay), Parekura Muraahi and Tash Kingi (Wanganui), Janette Pease, Whitney Henderson and Lathainia Picking (Manawatu), Brigid McKenzie (Kapiti) and Lee Adamson (Kapi-Mana).
- NNZ Performance Coach Qualifications (PCQ) were achieved by three Central Zone coaches, Tash Rowlands, Lee-Anne Taylor and Lisa Tod who were part of the first 11 people in New Zealand to achieve this new qualification.
- Three NNZ Advanced modules were held in Wellington – Advanced Skill Analysis, Mental Skills and Skill Acquisition, delivered by Adrienne Morrin, Dr Kylie Wilson, Anna Cave and Waimarama Taumaunu.
- Eight informal coach workshops were delivered throughout the Zone by Waimarama Taumaunu, Yvette McCausland-Durie, Dennis Slade and Sandra Edge.
- A highlight for the year was 'Think, Do, Grow', the annual coaching conference held in October at Massey University, Palmerston North. Over 50 coaches from around the Zone attended the event facilitated by presenters which included Kathryn Berkett, Waimarama Taumaunu, Adrienne Morrin, Irene van Dyk, Jo Holmes, Dennis Slade, Kirsten Hellier, Tania Karauria, Charissa Barham, Simon Chatterton, Ann Hay and Gareth Fowler.
- Our special thanks go to Central Zone's independent Coach Developers for their contribution and support this year, Karen Bevan, Tania Lister, Lisa Murphy, Tash Rowlands, Valerie Sampson, Ivy Topping, Charissa Barham, Adrienne Morrin.





## UMPIRES AND BENCH OFFICIALS

We would like to acknowledge and thank Linda Liggins and Anne Blomfield, our Netball Central Zone representatives on the New Zealand Umpire Development Group (NZUDG) and Bernice Robertson, Lisa Aull, Julie Shaw and Sam Kerins for co-ordinating Bench Officiating and Statistics in the Zone. To the Zone Umpire Development Group (ZUDG) and the Zone Technical Official Advisory Group (ZTOAG),

who play an integral role in the development of officials within our Zone, we thank you for your dedicated efforts in ensuring the Central Zone continues to grow in this area of expertise.

- Umpire development has again been well supported by the Centres in 2016 with several dedicated umpire development officers providing guidance and support in this specialised area.
- The NNZ Coach-Assessor workshops for umpires were led in our Zone by the NZUDG representatives in 2016, with administration being completed by the Zone. These workshops were significantly attended in the Zone by 87 umpire-coaches.
- Special congratulations to Bernice Robertson who was awarded the 2016 Outstanding Contribution to Technical Officials at the Netball New Zealand Awards in November.







## HIGH PERFORMANCE

**THE HIGH PERFORMANCE PATHWAY IN THE NETBALL CENTRAL ZONE (NCZ) STARTS WITH TALENTED SECONDARY SCHOOL PLAYERS BASED IN THEIR RESPECTIVE CENTRES AND CULMINATES IN A PROFESSIONAL CONTRACT PLAYING FOR THE PULSE.**

In 2016 NCZ was highly successful in the developmental part of our pathway – we dominated national selections

for the New Zealand Secondary Schools (NZSS) team, won the under-19 and under-17 age-group titles, dominated national age-group tournament team selections, provided five members of the Netball New Zealand (NNZ) under-21 squad and placed second in the inaugural Beko Netball League.

We anticipate that our successes in 2016 in growing emerging talent will help us to realise our

stated goal of producing a home grown Pulse team that wins by 2019.

The NCZ Performance programme has been highly successful as a direct result of the quality and efforts of our members, both paid and voluntary, from across the Zone. We are enormously grateful to the Centre General Managers, Development Officers, Selectors, Coaches, Officials, Umpires and



all the other support staff and volunteers who have given their time and energy to developing the most talented players across the Zone.

## PULSE

2016 was a disappointing season for the Pulse. We finished fifth in the New Zealand conference and ninth in the overall ANZ Championship, winning just two games and drawing two.

Roster changes at the end of 2015 saw the departure of seasoned veterans Joline Henry, Irene van Dyk and Liana Barrett-Chase. Unfortunately, injuries at the start of the new season meant that Jodi Brown did not take the court at all and midcourt stalwart Elias Scheres' (nee Shadrock) season ended earlier than anticipated. Accordingly, new coaches Tanya Dearn and Tania Hoffman faced a very challenging season from the outset with an inexperienced and untested team.

In the end, the largely new team and management staff were not able to develop sufficiently as a unit in the short amount of time that they had, to contest consistently against the more established teams in the competition.

However, there were some positives that came out the season. The upside of losing Jodi was that newcomer Maia Wilson was given an unexpected opportunity and she proved outstanding in her first ANZ competition, eventually achieving her first test cap for the Silver Ferns at the end of the year.

Also in the 2016 International Programme, Pulse captain Katrina Grant was elevated to the role of Silver Ferns captain. Grant was joined in the Silver Ferns squad by Pulse team-mates Ameliaranne Ekenasio, Phoenix Karaka and Maia Wilson.

## BEKO NETBALL LEAGUE

Netball New Zealand introduced the Beko Netball League in 2016 to strengthen its performance pathway by running a second tier competition alongside the ANZ Championship. It was in

this arena that the Central Zone shone, showing the benefit of the talent development work that has been burgeoning through the Zone in recent years.

The Central Zone Beko team was coached by Yvette McCausland-Durie (Manawatu) and comprised a squad of 16 players who practised as a team twice a week and completed comprehensive training programmes in small groups during the rest of the week. Each week coach McCausland had the unenviable task of selecting the playing roster of 10 for that week's game.

Our team was young but made up for a slight lack of experience with enthusiasm and energy. What we lacked in height and age we made up for in speed and conditioning.

The team played eight games, three at home and four away. They won five matches, lost three and ended the regular season in second place. Unfortunately, the team lost the final against Netball South going down 51- 46.

From this team, three players earned a call-up to the NZU21 squad – Tiana Metuarau, Mila Reulu-Buchanan and Kimiora Poi (Wellington). Karin Burger (Wellington), the team's standout defender, was named Beko Player of the Year by Netball New Zealand and was also added to the Silver Ferns Development Squad.

## NATIONAL AGE GRADE PERFORMANCES

In the 2016 National Under 19 Championships, Wellington Centre ran out convincing winners over Auckland in the final, winning 38-25. Taranaki, Hutt Valley and Manawatu also

attended and placed in the top 15. Jermaine Howard Vallance, Marcelle Parkes, Kimiora Poi, Mila Reulu-Buchanan and Api Taufa from Wellington Centre were named in the tournament team.

At the Under 17 National Age Grade Championships, the Central Zone was represented by 10 Centre teams, with seven of those achieving top 20 finishes in the 40-team competition.

Wellington Centre were once again to the fore in the final play-offs with Wellington Black defeating Auckland A in the event final, 27-21, and Wellington Gold beating Dunedin 30-22 to capture third place for a best-ever final placing. The Tournament team, unsurprisingly, was dominated by Central Zone players, with 10 of the 17-person group hailing from Central Zone Centres – Jaydi Chaffey-Taylor (Hawke's Bay), Lyric Faleafaga, Julia Law, Chynna Leota-Ah-Hin, Tiana Metuarau, Ainsleyana Puleiata, Renee Savai'inaea, Ruby Stirling (Wellington), Brooke Nielsen (Taranaki), Jessica Pease (Manawatu).

### SECONDARY SCHOOLS PERFORMANCES

At our marquee secondary schools event, the Lower North Island Secondary Schools Championship, 58 teams competed for the LNISS trophy and the honour of attending the National Secondary School Championships. At the end of the week-long tournament Manukura (Manawatu) defeated St Mary's College (Wellington) in the final; Wellington East Girls College, Palmerston North Girls High School and Wellington Girls

College rounded out the top five, all of whom had won the right to attend nationals.

At the National Secondary School Tournament, the Central Zone teams once again acquitted themselves with distinction, taking out three of the top six placings – Manukura 3rd, St Mary's College 4th and Wellington East Girls College 5th. Once again the Central Zone was to the fore in Tournament team selections with seven of the 18-person team being from Central Zone Secondary School teams. The team included Ainsleyana Puleiata, Lyric Faleafaga, Renee Savai'inaea and Saviour Tui (St Mary's College) Braxton Te Riini, Emily Autangavaia (Manukura) and Tiana Metuarau (Wellington East Girls' College).

Additionally, the positional Players of the Tournament were all from Central Zone teams. They were Shooter of the Tournament: Tiana Metuarau (Wellington East Girls' College), Midcourter of the Tournament: Ainsleyana Puleiata (St Mary's College) and Defender of the Tournament: Renee Savai'inaea (St Mary's College).

Perhaps unsurprisingly Ainsleyana and Renee were called into the NZU21 Squad at the end of the year, taking the Central contingent in the squad to five – more than any other Zone and more than we have ever had.

### SECONDARY SCHOOL TALENT IDENTIFICATION AND DEVELOPMENT

In 2016 Central Zone continued to refine our Secondary School player identification and development programme.

This year the programme involved more than 80 athletes, 25 coaches, 20 umpires and 10 selectors, all of whom participated in identification days held in Wellington, Palmerston North, Hawke's Bay and Taranaki during October and November. From this process, a number of players were selected to attend further development camps, alongside identified umpires and coaches who attended for their own learnings.

The National Secondary School selectors were also invited to attend to observe the performances of our players, to help in their national secondary school selections.

As a result of this collaboration, Netball Central Zone had eight of 24 trialists invited to trial for the New Zealand Secondary School team; we provided six of the final 12-person team that contested and won the International School Girls Tournament in Auckland; Tiana Metuarau, a Beko team member, was named Shooter of the Tournament; and at the same tournament the Zone also provided half of the AMNOHL Maori Secondary School team, who finished third behind Australia.

At the age-group and secondary school level, our achievements were unrivalled by any other Zone in the country and provided evidence of the progress we as a Zone have made in High Performance. We will continue working hard in this area to support our High Performance objective of winning the ANZ Premiership by 2019 with a home-grown team.



# MAINTAIN FINANCIAL SUSTAINABILITY

The environment in which we operate continues to be challenging but the Board and management retains its unwavering commitment to building a financially sustainable future for Netball Central Zone.

## LONG-TERM FUNDING STRATEGY

Securing consistent and on-going funding is a perennial challenge across the Zone with many of the participants often competing for the same funds. However, Netball Central Zone continues to work side-by-side with a wide and varied cross-section of stakeholders and funders for the betterment of netball.

## SET AND MEET TARGETS

The financial result for the year ending 30 November 2016 was a surplus of \$15,718 against a budgeted deficit of \$149,456. This is another pleasing result following on from last year's

surplus and our commitment to operate within our means. Key drivers in the overall result occurred from savings in player payments, staff vacancies, not making the playoffs, increased grant funding and some additional sponsorship not budgeted for.

## NETBALL AN "AFFORDABLE" SPORT

Affordability for those playing the game is always a major consideration for Netball Central Zone. Every effort is made to ensure it remains a sport for all and each year we review the fees we ask of our community. However, this has to be finely balanced alongside the financial sustainability of the Zone.

## TARGETED MARKETING

The success of the Zone is dependent on the mutual support of a number of stakeholders, the role of the funder and sponsors

being a key ingredient. With the introduction of the Beko Netball League, this was especially true and having the support of Lion Foundation, Trillion Trust and Brendan Foot Supersite all contributed to the overall success of this programme. Securing partners that buy into our vision of expanding opportunities for women in sport and leadership remains an important part of Netball Central Zone's future agenda.

New Zealand Community Trust and Infinity Foundation have been strong supporters of netball and the Zone, their ongoing support to the game ensures that we are able to be a success on and off the court.

As we grow our sponsorship and funding base, and deepen the connections with our community, we are excited about how we will be able to offer more opportunities for girls and women in the Zone that will be mutually beneficial.

# SUSTAIN & GROW ORGANISATIONAL CAPABILITY

## LEADERSHIP, GOVERNANCE, MANAGEMENT

During the year, we accepted the resignation of Norah Barlow, an appointed member of the Board. Norah's wealth of business experience provided invaluable input into the governance structure and the commercial aspects of the Zone.

Sue Gould agreed to extend her term as an elected member for a further year, ensuring ongoing continuity of the Board.

There was significant engagement with Netball New Zealand during 2016 as changes to the premier competition in New Zealand unfolded during the first half of the year.

## FURTHER DEVELOP POLICY AND PROCEDURES

With the introduction of the new Health and Safety At Work Act in April this year, there has been considerable work undertaken to implement the Zone Health and Safety manual, together with a number of policies and procedures. Regular reporting to the Board as well as staff updates have continued to see the Zone refine our health and safety practises in regards to the processes we have in place for all staff to go about their roles in and out of the office.

## DEVELOPMENT AND RETENTION OF STAFF

We bid farewell to some familiar faces during 2016 while welcoming some new additions to the staff.

Lizzie Sandom resigned from her role as Events Manager in October to take up an opportunity with the Wellington Regional Economic Development Agency and was replaced by Vai Tuita'alili at the end of October.

Frances Solia left her position as the Performance Manager in August to take up a sport's co-ordinator role. Natalie Milicich joined us in November, taking up the roles of Performance Manager and Head Coach of the Beko Netball League team. Natalie has just completed a degree in Sport and Recreation at the Auckland University of Technology (AUT) and feel very fortunate she has moved to Wellington to join us at Netball Central. An experienced campaigner, Natalie has previously spent over 20 years coaching at school, club and representative level in Auckland.

Former Silver Ferns shooting supremo Irene van Dyk started with us in January as the Junior Development Officer. Irene is Netball New Zealand's ambassador, her extensive playing career, positive attitude and willingness to pass on her enthusiasm for the game an infectious attribute for many of those she comes into contact with.

Aimee Henderson started with us in March in the new position of Office Manager, her key responsibilities include the overall management of the office, Health and Safety, and the administration of the Community Coach Award modules.

Former Silver Ferns coach and captain Wai Taumaunu started with us in October as High Performance Director, overseeing both the Pulse and Beko programmes, the Performance Manager reporting directly to her. Wai brings with her an extensive level of knowledge and expertise both in netball and management and we're delighted to have her on board.

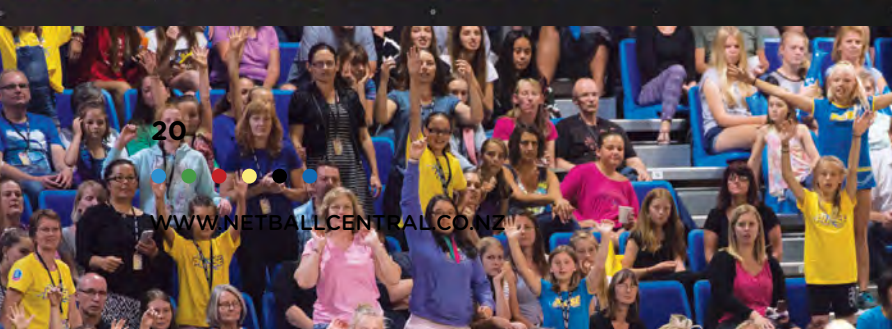

## Notes to the Financial Statements

### For the Year Ended 30 November 2016

#### 1 Accounting Policies

##### *Basis of Reporting*

Netball Central Zone Incorporated (NCZI) is an Incorporated Society in New Zealand, incorporated in 2012. NCZI is a Public Benefit Entity.

The special purpose financial statements have been prepared in accordance with s23(l) of the Incorporated Societies Act 1908.

The special purpose financial statements have been prepared applying the accounting principles of accrual accounting and the double entry method of recording of financial statements. They comply with the New Zealand Tax Administration (Financial Statements) Order 2014.

The special purpose financial statements have been prepared on the basis of historical cost.

The financial statements comprise of Statement of Financial Position and Performance, movements in equity and accounting policies as well as the notes to these statements and comply with the Tax Administration (Financial Statements) Order 2014. The financial statements are presented in New Zealand Dollars (NZ\$).

##### *Going Concern*

The financial statements have been prepared on a going-concern basis, reflecting the Board's business plan which is being monitored monthly to ensure sufficient cashflow is available to pay liabilities as they fall due.

##### *Goods & Services Tax*

Figures shown in these financial statements are exclusive of GST, with the exception of accounts receivable and accounts payable.

##### *Revenue Recognition*

Revenue that does not relate to the current period is deferred on the statement of financial position as income received in advance until such time as it is appropriate to recognise the revenue.

##### *Contra*

Contra received is recognised as sponsorship revenue when amounts are quantifiable in terms of the sponsorship contract.

##### *Accounts Receivable*

Accounts Receivable are shown at an amount which represents their estimated realisable value.

##### *Plant, Equipment and Depreciation*

Plant & Equipment is stated at cost less accumulated depreciation. Plant & Equipment have been written off over their estimated useful lives on a straight line basis to calculate the depreciation charge for the period as follows:

##### *Uniforms*

Uniforms are expensed at the time of purchase.

##### *Taxation*

NCZI is a Non-profit body for taxation purposes under section CW 46 of the Income Tax Act 2007 and as such no taxation is payable on the profit for the year.

##### *Changes in Accounting Policies*

There has been no change in accounting policies during the year and they have been applied on a consistent basis.

##### *Consolidation*

Netball Central Zone Incorporated is consolidated with Central Netball Region (CNR).

The Zone is the operating entity and CNR is a debt only entity. Related party transactions exist between the two entities and have been eliminated upon consolidation.
